RE: *Parsons v. Shinn*
COVID-19 Practices at ASPC-Tucson
Failure to Have Necessary Medical Equipment.

Dear Mr. Bojanowski:

We write regarding several medical practices that have arisen recently at ASPC-Tucson that raise serious concerns about the institution's ability to provide ongoing chronic and infirmary care to class members, as well as an inability to follow CDC guidelines for the management of COVID-19.

Mixing the Populations of People Who Need Medical Isolation and Those Who Need to Quarantine

First, according to the medical records of multiple class members, it appears that the Manzanita CDU is currently being used for both the medical isolation of symptomatic class members suspected of having COVID-19 and for the quarantine of asymptomatic class members who may have been exposed to COVID-19 during community hospitalizations. We note that the CDC Interim Guidance on Management of Coronavirus Disease 2019 (COVID-19) in Correctional and Detention Facilities states explicitly that "medical isolation and quarantine locations should be separate."¹

Plaintiffs' counsel previously notified you of dangerous practices at other prisons where quarantined suspected positive patients were apparently housed together with

medically isolated patients as well as the asymptomatic persons normally assigned to those living units. (See, e.g., 4/16/20 Letter from A. Fettig to R. Love re: overcrowded detention units at Lewis-Morey and Bachman Detention Unit; Safford-Miles Detention Unit; and Tucson-Cimarron, Winchester, and Complex Detention Units; 4/21/20 Letter from D. Fathi to T. Bojanowski re: Florence Kasson Unit; 4/23/20 Letter from D. Fathi to T. Bojanowski re: overcrowded units at ASPC-Phoenix Alhambra and Baker Units). Defendants have failed to respond to these letters, and according to today's Daily Count Sheet, detention units continue to be overcrowded. See Attached Count Sheet, available at https://corrections.az.gov/sites/default/files/DAILY_COUNT/May2020/05012020_count_sheet.pdf (showing Tucson's Complex Detention Unit, with a capacity of 80, has 93 people in it; Tucson's Cimarron Detention Unit, with a capacity of 96, has 107 people in it; and Yuma Cheyenne Detention Unit, with a capacity of 79, has 84 people in it).

By way of example, Mr. ██████████ ADC ██████████ is a 76-year-old class member with cancer, asthma, chronic obstructive pulmonary disease (COPD), and several other serious medical conditions that put him at high risk of getting sick or dying from COVID-19 should he become infected. According to his medical records, Mr. ██████████ was hospitalized at Banner University Medical Center South from April 13, 2020 to April 16, 2020 for decreased oxygenation. Upon his return to ASPC-Tucson on April 16, Mr. ██████████ was initially admitted to the Manzanita CDU. Notes from medical staff indicate that he was diagnosed with influenza B and pneumonia at the hospital but ruled out for COVID. Additional notes state, "Patient in CDU for ISO due to admission to Banner hospital and possible contact with COVID 19."

The medical records indicate that the next day, on April 17, Mr. ██████████ was moved from Manzanita CDU to the Rincon IPC for "14 day isolation." On April 20, NP Alonso discharged Mr. ██████████ from the infirmary, even though he was only on his third day of medical isolation. Mr. ██████████ was then apparently moved back to the Manzanita CDU.

No Oxygen Concentrator at Tucson-Manzanita Unit

On April 26, an ICS response was called for Mr. ██████████ whose oxygen saturation levels had dropped to a very dangerous level of 79%. The notes by LPN Alderette state that after Mr. ██████████ oxygen saturation levels continued to be "unfavorable" following medical intervention, the Manzanita CDU medical staff then contacted NP Redwine to notify her that they "do not have a working concentrator available at this time." NP Redwine apparently instructed LPN Alderette to contact the IPC to have Mr. ██████████ moved there for 24 hour observation, "as long as a bed was available to him." LPN Alderette's complete objective notes are reproduced below:

Objective Notes

IM O2 saturation 79% on initial read, after breathing tx and inhalers, IM O2 up to 82 on Room air, reads were made of different fingers, IM advised to drink more water to increase his BP and perfusion to extremities, after all treatments had been done and he has continues to drink, O2 still unfavorable so NP Redwine contacted and notified that we do not have a working concentrator available at this time. IM put on 2 L O2 and sating at 92%. NP Redwine advised writer to contact IPC to have IM goes to their observation for 24 hour obs, as long as a bed was available for him, as more medical staff are available to check in on IM with higher frequency. IPC contacted and advised they had room for IM in C10. IM advised to drink more water to increase his BP and perfusion to extremities. Before he departed unit VS were retaken BP 112/72, 71 pulse, O2 92 on 2 liters. IM transported via DOC van in wheel chair stating he cannot walk, with O2 tank at 2L and proper PPE.

Unfortunately, Mr. ██████ condition continued to deteriorate at the Rincon IPC, and his oxygen saturation levels continued to decline. His medical records indicate that he was sent out to the hospital for emergency medical care in the evening on April 26, and he remains at the hospital today.

We are gravely concerned that the Manzanita Unit – which has a 45-bed special needs unit within it – does not have a functional oxygen concentrator. In Mr. ██████ case, he was apparently sent to the Manzanita CDU for medical isolation after being diagnosed with influenza B and pneumonia, and after medical staff determined that he had possibly been exposed to COVID-19 during his hospitalization. Given the serious health needs of Mr. ██████ and all other patients being incarcerated in the Manzanita CDU because of suspected COVID-19, it is imperative that Manzanita be supplied with functional medical equipment necessary for patient care.

The CDC’s Interim Guidance on Management of Coronavirus Disease 2019 (COVID-19) in Correctional and Detention Facilities states that, “staff evaluating and providing care for confirmed or suspected COVID-19 cases should follow the CDC Interim Clinical Guidance for Management of Patients with Confirmed Coronavirus Disease (COVID-19) and monitor the guidance website regularly for updates to these recommendations.” The referenced Interim Clinical Guidance from the CDC names people with chronic lung diseases like COPD as among those who are at higher risk for severe illness from COVID-19, and states that they should continue to take their medications and to avoid triggers that would worsen their symptoms.² As supplemental oxygen is a treatment option for people with COPD,³ it is necessary that class members housed in the Manzanita CDU, and all other units being used for medical isolation for confirmed or suspected

COVID-19 cases, be provided access to supplemental oxygen as needed given their medical conditions.

We request that staff procure a functional oxygen concentrator for ASPC-Tucson Manzanita Units and for all other units being used for medical isolation of confirmed or suspected COVID-19 cases in ADC state prisons.

We ask that you confirm receipt of this letter, and provide an update as to when staff have procured functional oxygen concentrator at ASPC-Tucson Manzanita CDU and at all other ADC state prisons. Thank you for your attention to this matter.
